

Psychological support policy Al-Farabi KazNU

Policy on Psychological Services in (hereinafter referred to as the Policy)

NAO "Al-Farabi Kazakh National University" (hereinafter referred to as the University) is based on several laws, regulations, developments related to the problems of modern youth and the need for a specially organized social psychological work in educational institutions aimed at the socialization of students, their integration into society, the formation of various aspects of their social identity (professional, gender, civil, national, etc.). The legal basis is the Law of the Republic of Kazakhstan dated July 27, 2007 "On Education", the resolution of the Supreme Council of the Republic of Kazakhstan dated June 8, 1994 "On ratification of the Convention on the Rights of the Child", as well as these Rules.

The organization and coordination of psychological support activities are carried out through the following normative documents:

Analysis of the current situation

During the reporting period, the socio-psychological service of the university was actively functioning at the Al-Farabi Kazakh National University, individual psychological consultations were conducted for students with psychological problems. Psychological assistance was provided for 17 students.

Training seminars were held for students, including: "Ludomania, consequences, causes and symptoms" and "My choice" a training seminar on the prevention of smoking and alcoholism, organized by the socio-psychological service sector together with the center "Social Project Management" within the framework of the project "Healthy lifestyle" of the Department of Youth Policy of the city Almaty (01-16.11.2022).

On February 9-10, 2023, an employee of the sector took part in a forum aimed at the development of student youth, organized by the Ministry of Science, Higher and Postgraduate Education of the Republic of Kazakhstan.

From January 23 to February 13, 2023, lectures on psychology were held for students in the classrooms of 16 faculties, aimed at self-knowledge, an active lifestyle, solving life ailments, and the formation of students' personality. The lectures consisted of 16 topics. The topics covered five main areas of psychology: Art therapy, logotherapy and existential analysis, neurobiology, social psychology, socio-cultural theory of personality.

On 02/27/2023, an online questionnaire was created on the Google form platform. The questionnaire consisted of 11 questions. The purpose of the questionnaire is to identify students' requests, life values, ideas, worldview, etc. Based on the analysis of the answers to the questions of this questionnaire, many students of the university revealed a positive attitude to the world around them. In the future, according to the analysis of the questionnaires, seminars and trainings on relevant topics will be organized.

From 13.04.2023 to 25.04.2023, together with psychologists from Almaty universities, events were organized and held: a pilot version of the "Express Psycho" collaboration. In the collaboration, psychologists used psychological techniques such as: "MOCK maps", "Sand therapy", "Neurography", "Existential analysis and logotherapy". The aim of the project is the formation of a culture of appeal to psychologists among students. Free psychological assistance was provided to students of such universities as: Al-Farabi Kazakh National University, AUES, Satbayev University, Academy of Civil Aviation, Kurmangazy Kazakh National Conservatory.

24.05.2023The university psychologist A.Tastanov took part in the forum "The work of the psychological service of the university in modern realities" organized by the Suleiman Demirel University (SDU).

- from 08.06.2023 to 20.06.2023, collaborations "Express Psycho" were organized and conducted together with psychologists of Almaty universities. Free psychological assistance was provided to employees of the following universities: Al-Farabi Kazakh National University, AUES, Satbayev University, Academy of Civil Aviation, Kazakh National Conservatory.

Scope of application

This Policy applies to:

- University students, including students with disabilities and international students;
- the teaching staff of the University, including for the teaching staff and staff with disabilities and for foreign teaching staff,
- all full-time and temporary employees, contractors, heads of structural divisions, officials, directors and business partners, as well as third parties hired or engaged by the University or providing services on behalf of the University.

Implementation and compliance

This Policy is an integral part of the principles and approaches provided for in other policies and procedures of the University regulating social aspects. Violation of this Policy will result in the application of serious disciplinary measures, including, inter alia, dismissal, in accordance with the applicable legislation, as well as internal policies and procedures of the University. In accordance with the requirements of internal regulations, the University conducts familiarization and regular training regarding the application of policies and procedures governing the approach to diversity and inclusivity.
